- Encourage our workforce to work safely and report all accidents, incidents, hazards and near misses to our HSQE Department.
- Measure our safety performance, share trends and results to drive continual improvement.
- Undertake annual assessments of policies, procedures, method statements, risk assessments, and COSHH assessments.
- Be committed to providing Safe plant & equipment that is maintained, Safe working environments, Information, Instruction & Training for all employees, to ensure they have the necessary skills to conduct activities in a safe manner, planning safety issues into our operations prior to commencement of operations.

- Provide occupational health assessments for our workforce to ensure they are fit for work.
- Provide adequate Health and Welfare facilities for on- and off-site works.
- Regularly test and review our emergency procedures for fire evacuation and first aid.
- Ensure our working environment supports health and safety practices including safe access and egress of fleet and plant.
- Ensure the Health and Safety Policy will be made available to any interested parties and will be reviewed on an annual basis or after changes in legislation, re-communicating the reviews to all employees and stakeholders.
- The company Director commits to providing adequate financial and physical resources to ensure proper delivery of the policy and management systems.
- Ensure monitoring of Health & Safety matters takes place in the following manner:
- o Directors Will regularly visit site and complete a senior managers Inspection document.
- o Operations Manager Will regularly visit site and complete a Line Mangers Inspection document.
- \circ $\$ HSQE Manager Will visit site monthly and complete a HSEQ inspection Document.
- Team / Gang Self-Assessment On a daily basis each team leader will complete a Team / Gang Self-Assessment document.
